Remaining fees i.e. Other fees / College fees also be paid in INR. In place of UTR No, Demand Draft No / Date which corresponds to US\$ 5000 be mentioned while registering for the course, in addition to UTR No. generated for payment towards Other fees / College fees.

- 1. All students are requested to select correct fee category from drop down options. Don't select wrong fee category, it will trouble both of us. Be careful before selecting the fee category. If you have any doubt, do contact. Accounts Department.
- All students are instructed to keep the College Fee Receipts with them till they graduate. The same should be produced on demand by College authorities, as and when requested in future. If the students has paid college fee after the due date penalty will be Rs 1000/-.
- 3. It is advised to maintain soft (scanned) copies of fee receipts on various e-modes/media like, e-mail, WhatsApp etc., which will help you at the time of "No Dues" clearance. A penalty of Rs. 200/- one is required to pay for duplicate fee receipt per year, (in case you lose the original fee receipts), can be saved if the copies are preserved as advised herewith.
- 4. All category students are requested to comply with scholarship / free-ship formalities immediately on receipt of notice / e-mails/Circulars & fill up the online forms. All students should read notices sent through college email id, uploaded on Institute's website and/or displayed on institute's notice board from time to time. Do not submit any document to Accounts Department without acknowledgement including scholarship forms. Mere ignorance will not be entertained / excused. Such students are advised to keep in touch with their respective faculty advisor/mentor, the peers and Accounts Department Staff for Scholarship / Free ship compliances, as applicable, from time to time.
- 5. In case, certificate such as caste validity/non-creamy layer (as applicable) is not submitted at the time of admission, full fees have to be paid compulsorily. Re-imbursement can be claimed after submission of the required documents during the period of the course and subject to the approval of concerned authority for the same. For any difficulty student to contact respective faculty advisor/mentor and Accounts Department.
- 6. All category students who have paid their fees as per category during their S.Y. B Tech regular students but have not submitted the Scholarship / Freeship Forms for whatever reason, are instructed to pay the remaining fees i.e. Difference of Open Category Fee and Category Fee immediately. EBC students should note that if their respective parents income was more than 8.00 lakhs during the previous financial year, then such students must pay open category student fees.
- 7. All year down B. Tech Students who have paid their four years fee in full & M. Tech Students who have paid their two years fees in full, will be eligible for <u>Semester Pattern Fee.</u> They are instructed to pay the semester-wise fee with prior approval from Exam Cell and Accounts Department. If any student is found by-passing the above rule, will invite disciplinary action.
- Students who have availed concession for part payment from higher authority in the past and till date have not paid the balance fee, their further registration will not be processed. Such defaulting students are requested to contact the Accounts department over e-mail immediately. Such students should also note that, approval for part fees submission, for this year, will be given only after fees for earlier years is paid fully.
